

## **BCBS Secure Website for Employees – MyWellmark.com**

With myWellmark, you'll find all your health and wellness information in one place. Our secure member website gives you quick, easy access to check claims, review your benefits, and track your health care expenses. You'll also find tools to help you learn about your health and reach your health goals.

### **7 Reasons to Register for myWellmark**

1. Check claims and know if they've been paid - Has your claim been paid? Do you owe any towards your deductible? How much? The most convenient way to get your financial questions answered is to log in 24/7 and see.
2. See if a procedure is covered - Coverage for certain services and procedures can vary, depending on your plan. Some treatments — like chiropractor visits — are limited to a certain number during a benefit period. Log in to find out what's covered.
3. Ask a question through secure channels - With our "Ask and Track a Question" tool, you can ask about specific claims, include personal health information, and mention prescriptions — all in a safe and secure environment.
4. Help save a tree - When a provider submits a claim and we process it, we mail you a statement called an Explanation of Benefits (EOB) to show how your benefits were applied. You can sign up to receive them electronically instead, and we'll send you an e-mail when a new one is ready to view. Nearly 40,000 Wellmark members have already signed up to receive EOBs online.
5. Check the prices of your prescriptions - If you have Wellmark drug coverage, you can find out how much you'll pay for your prescription — before you even fill it. And if you're taking a brand-name drug, you can find out whether there are generic options that can save you money.
6. Enjoy member discounts - As a Wellmark member; you have access to discounts and services through Blue365, a program designed by the Blue Cross Blue Shield Association. Jenny Craig, Anytime Fitness, Reebok, Westin hotels, LasikPlus, and dozens more discounts are available for you.
7. Review your health care costs - Run reports on your total health care costs and see how much you've spent out of pocket. Use this information for tax purposes, or to plan your contributions to a flexible spending or health savings account. You can also check how close you are to meeting your deductible or out-of-pocket maximum.

### **How to Register for myWellmark**

- Go to <http://www.wellmark.com/Member/index.aspx> Registration takes just 5 minutes. You'll need your Wellmark ID card to get started.
- Under the Log in to myWellmark; select Register now
- Have your Wellmark ID card handy and enter the details exactly as shown.
  - You will need to provide some basic information about yourself. Fill in the form with your name, birth date and contact information.

- To ensure only you have access to your personal health information, we ask you to enter the last four digits of your Social Security number and your relationship to the primary member (self, spouse, dependent). You can be sure we keep this information safe and confidential.
- Pick your communication preferences. Choose whether to receive electronic communications from us and, if you're the primary member, to receive explanation of benefits (EOB) statements online.
- Create Account
  - Set up your myWellmark User ID and password. You'll need your User ID and password every time you want to access your myWellmark account.
  - You'll also choose and answer security questions. These will help us identify you if you ever forget your User ID or password.
  - Accept the terms and conditions for using myWellmark, then submit your registration.

That's it! Next you'll be taken your myWellmark home page, where you'll learn about how to customize the site to get the most benefit from it.
